Last month, a Winnebago County jury was asked to award \$12,500,000 to the Estate of Karen Williams, a 42-year-old attorney who was killed when three armed robbers fleeing the police crashed into her car and killed her.

The Williams Estate sued the Boone County Sheriff over the actions of its deputy who engaged in the high-speed pursuit. However, the Estate elected not to sue the three armed robbers who instigated the chase. James Devine and Joel Huotari represented the Boone County Sheriff at trial.
